Sub: Issue of No Objection Certificate for the establishment of Leelavathi Shetty College of Education at Mangalore for the academic year 2007-2008.

Ref: Letter No. MU/Acc/Aff/22/2005/06/A1, dated: 27-03-2006 received from the Registrar, Mangalore University, Mangalore-574 199.

PREAMBLE:


1) The State Government has lifted the ban on issue of *No Objection Certificates* for establishment of B.Ed/B.P.Ed colleges in all mediums of instruction from the academic year 2003-2004 in G.O dated: 29-04-2003. As a sequel to this, the Universities were directed to advertise calling for applications for establishment of B.Ed/B.P.Ed colleges for the academic year 2003-2004 and to submit them to Government after complying with the procedure stipulated in Section 59 of the KSU Act, 2000, to enable it to consider for grant of NOCs under regulations 5 (e) of the NCTE Regulations 1995. The proposal of Dr. M.V. Shetty Memorial Trust, A.B. Shetty Circle, Mangalore-575 001 to establish Leelavathi Shetty College of Education, Air Port Road, Kavour Junction, Mangalore-575 015 had been recommended by Mangalore University. The proposal has been examined.

2) Hence the following order.

4) Government of Karnataka is pleased to grant issue *No-Objection Certificate* to Dr. M.V. Shetty Memorial Trust, A.B. Shetty Circle, Mangalore-575 001 to establish Leelavathi Shetty College of Education, Air Port Road, Kavour Junction, Mangalore-575 015 for offering B.Ed course with an intake of 100 (One hundred) from the academic year 2007-2008 under Regulation 5(e) of the NCTE Regulations 1995, subject to the following conditions:-

(1) No grant-in-aid shall be sought from Government for running the proposed college; it shall be subject to permanently unaided policy of the State Government. The institution shall give an undertaking to Government to this effect at the time of sanctioning affiliation based on the recognition to be granted by the NCTE-SRC.

- (2) The institution shall provide adequate infrastructure, staff etc., as per the norms and standards, prescribed by the National Council for Teachers Education and also the affiliating University;
- (3) The institution shall abide by the orders/rules of the State Government and the statutes and regulations of the affiliating University issued from time to time with regard to admission policy and recruitment of staff to the institution etc;
- (4) The institution shall collect 'Tuition fee' and 'Other fees' as prescribed by the State Government from time to time. The amount collected shall be utilized by the institution in accordance with rules;
- (5) The management should start the institution only after obtaining recognition from the National Council for Teacher Education under Section 14 of the NCTE Act, 1993.
- (6) The conditions stipulated in the LIC report shall also be adhered to by the institution.
